Due to this stopped responding to Suspect's emails and called your affiant to the home to investigate further.
In addition to the emails provided Affiant with text messages dating back to 5-10-2024. All text messages provided by are incorporated herein as "Exhibit B."
Several times between 05-10-2024 and 08-13-2024 Suspect makes statements to harm if she refuses to allow him back into her life or let him move back into their continue their life as a
In multiple messages states that she is refusing to rekindle her relationship with Suspect, citing prior incidents of violence, prior threats of violence towards her, and prior threats of violence in front her their making serious allegations about Suspect's prior violence and threats of violence, Suspect never denies or attempts to minimize her allegations. Instead, Suspect would continue the conversation trying to coerce her back into a relationship.
Excerpts of the text conversation between and Suspect include the following exchanges (See Exhibit B for the complete messages):
From the point 5-11-24: "You threatened my life! You scared because he heard that!!!" "What the hell!" "I will never trust you."
Suspect responded:
From the state on 6-4-24: "When I think of cold and heartless, I think of someone who physically hurts another and promises to fix things, and then two nights later is fucking Stef in her (or his) police car while she is working off

Importantly, prior to most of the above text messages being sent, On 5-15-2024 tells Suspect to "Please stop sending harassing texts. If you want to have a conversation about the please text. Otherwise you have no reason to contact me." On 5-17-2024 emphasizes that message by saying "I want to limit the manipulation and games." "I will reiterate this from my previous texts and our recent phone call, if you contact me by phone, I will record our conversations and will let you know at the beginning of the call each time, but if you need to contact me email me. You may text me if it's regarding the You are not to come out here unless I give you permission."					
This sentiment is emphasized several additional times over the next several months, but despite her wishes regarding contact, Suspect continues to text, call, and email in a threatening and harassing manner. Over the course of the following months, the texts continue to become more threatening and harassing in nature with suspect making the following threats:					
From on 6-6-2024: "Brian I'm just trying to live my life in the aftermath of everything. You I sit on rehasning everything."					
Suspect responds:					
From on 6-19-2024: "Brian, I am not seeing you tonight. Please stop these threatening conversations. Text me regarding the only."

On 6-28-2024 makes reference to being called a "stupid fuck" by Suspect. When your Affiant asked what that is in reference to, stated that she had a phone conversation with Suspect where suspect threatened to kill her. As per her prior warnings, recorded the phone call between herself and suspect. Your Affiant listened to the call and on that call, Suspect tells that

Suspect Responds:					

Later on 6-29-2024, when is not responding to Suspect. Suspect states the following:
On 7-3-2024, while attempting to convince to let him back into her life, Suspect states
responds: "Please stop Brian. Let me go. We are done. You need to let me go so you can move on with Annie. She is fabulous. Stop contacting me regarding our relationship that is no more. Please
From on 7-11-2024: "Brian, what you did today was corossing the line. You blew the line up. Brian when you tell me that you will kill me unless I give you another chance is not you being good. You are terrorizing me and held me hostage in the house today. You can't do this to me anymore. Please stop. You want to be a good person then show me by being a Please stop hurting and threatening me."
Suspect responds:
When asked what these and several following messages were in regards to explained that, on 7-11-2024 Suspect came uninvited to her house in his marked JSO patrol car, in his JSO uniform, wearing his JSO service weapon. Once there, he began beating or back door. The reluctantly let Suspect into her home where initially they had a civil conversation. According to that conversation eventually shifted to a threatening conversation where suspect reiterated that if would not get back with him he would kill her then and there. At one point, when told Suspect that she would not get back with him, Suspect told her to go outside so he could "take care of it." It is refused and sat at a computer chair with her back to Suspect because she believed that Suspect would be less likely to kill her if he had to shoot her in the back. While suspect was threatening her, the states that he was snapping and unsnapping the holster carrying his service pistol in an overtly threatening manner. It is states that she was in fear for her life and believed that Suspect was going to kill her. It is also states that did not feel she was free to leave and that she was confined in her home. Additionally, was able to activate the record feature on her phone and she has a recording of this encounter saved.
The texts following the message on 7-11-2024 provide corroboration to the above:
From on 7-12-2024: "Brian I need you to gain sanity. You threatened to kill me yesterday. Go live your live with Annie and grow with her."

When asked Stated that she took these messages as a threat that Suspect may take drastic actions against her to include killing her.

In a text message sent on 8/11/2024 Brian states:					
This message came after 39 consecutive messages were sent by the suspect without a response from Many of these messages are in a harassing in nature. On each day following the above message on 8-11-2024 Suspect sends a message counting down the days to 9-24-2024.					
On 8-13-2024 blocked her phone from receiving any additional messages from Suspect and told Suspect "I am blocking you. Do not contact or show up at the house."					
Following blocking Suspects messages Suspect began emailing On 8-13-2024 Suspect sends an email to that includes the sentence Suspect signs the message "Brian Housend."					
The following day Suspect sends an additional email that includes the phrase					
Further, it is worth noting that, per Suspect has a "Type 03 FFL," a type of federal firearms license that allows suspect to own types of firearm, and suppressors for those firearms, not lawful for persons without said FFL. Victim states that she knows Suspect to have a collection of firearms including an estimated twenty to thirty guns. It's based on this information, as well as the history of violence and the relentless pattern of harassing and threatening messages that makes suspect believe the threats contained in the messages are credible threats.					
After review of both the emails and texts it was determined that, the defendant willfully, maliciously and repeatedly harassed the victim and in doing so, made multiple credible threats with the intent to put the victim in reasonable fear of death and physical injury.
