**Additional Information**

On 09-10-2024, the JSO Internal Unit received a complaint from the victim in which she alleged misconduct by the suspect. Due to the nature of the allegation the JSO Integrity Unit was assigned to investigate the incident.

On 09-24-2024, an arrest warrant was issued for the suspect and he was taken into custody. The warrant reads as follows:

On 09-10-2024, the Jacksonville Sheriff's Office Internal Affairs Unit received a complaint from the victim, in which she alleged misconduct against the suspect (Officer Reginald McKinney). The victim's complaint stated the suspect pulled her over for not having current insurance and a suspended license. The victim stated during the traffic stop the suspect told her that he had turned off his body worn camera. He then told her that he could take her to jail but he was not going to and then asked her to step out of her vehicle. The victim stated that the suspect told her to follow him back to his vehicle where he showed her on his laptop computer that her license was suspended and there was an order to seize her tag but he was not going to and began complimenting her appearance, stating that she was "fine as hell." The victim stated as she began to walk back to her vehicle the suspect asked for her phone number and **F.S.119.071(2)(C)** The victim advised the suspect **F.S.119.071(2)(C)** and told her to follow him around the corner. The victim stated she complied and when they arrived on the side street, the suspect exited his vehicle and **F.S.119.071(2)(C)**

Due to the allegations being criminal in nature, your affiant was assigned to investigate. BWC video of the traffic stop was reviewed and the suspect is seen contacting the victim. After obtaining her information the suspect returns to his vehicle and while seated in the vehicle he is seen turning his laptop toward the passenger side of the vehicle. The suspect then turns off his BWC and there is no other video beyond this point.

**F.S.119.011(3)(a)** him in the 5000 block of Highway Ave., which was the location of the traffic stop. After approximately eight minutes the suspect begins travelling west on Highway Ave. and turns south onto Cynthia St. where he stops. The suspect is at this location for approximately two minutes and then leaves the area.

Your affiant also obtained video surveillance from a RTCC Camera located near the intersection of Highway Ave. and Ellis Rd. S. The video shows a marked patrol car and a small red sedan both travelling west on Highway Ave. during the time in question. The vehicles then both appear to turn onto Cynthia St.

On 09-19-2024, your affiant met with the victim and spoke to her about the allegations. The victim advised during the traffic stop the suspect told her that he had turned off his body worn camera and asked that she walk back to his vehicle. The victim stated she complied and went to the passenger side of the suspect's patrol vehicle where he showed her that her license was suspended and there was an order to seize her tag. The victim advised the suspect was telling her how attractive she was and requested her phone number. The suspect then asked that she follow him around the corner [REDACTED] F.S.119.071(2)(C) The victim stated she complied and followed the suspect. After stopping on the side street the suspect walked back to her vehicle where she was standing and [REDACTED] F.S.119.071(2)(C) The victim stated [REDACTED] F.S.119.071(2)(C) The victim advised the suspect then got back into his vehicle and left the area. The victim stated throughout the encounter with the suspect she felt fearful by the suspect's statement that he had turned off his body worn camera. The victim advised that due to his statement, the time of night and the isolated location, she felt she had to comply with his request. The victim stated this is the only reason she provided her phone number and followed him to the location on Cynthia St.

In speaking with the victim, your affiant found her statements to be consistent with the written complaint that she submitted on 09-10-2024. It should be noted that the victim's statement about going to the passenger side of the suspect's vehicle and viewing his laptop computer is consistent with the BWC video in which the suspect is seen turning his computer to the passenger side. The victim also identified the location where she followed the suspect to and [REDACTED] F.S.119.011(3)(a) [REDACTED] Your affiant was also able to view two text messages from the suspect that he sent to the victim after the traffic stop.

On 09-24-2024, your affiant met with the suspect and conducted a recorded interview. Initially the suspect advised [REDACTED] F.S.119.071(2)(C) [REDACTED]

After questioning the suspect was transported to the PDF and booked.

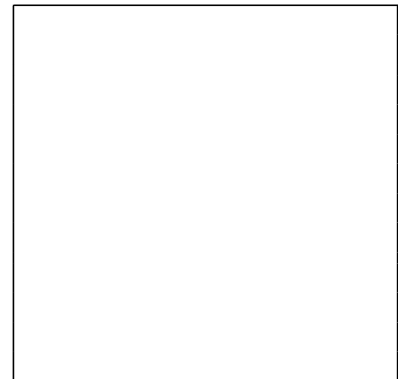
