IN THE NAME OF AND BY AUTHORITY OF THE STATE OF FLORIDA, MELISSA W. NELSON, State Attorney for the Fourth Judicial Circuit of the State of Florida, in and for Duval County, charges that:

COUNT 1

RAMON GERARDO CERDA on January 14, 2023, in the County of Duval and the State of Florida, did drive or was in actual physical control of a vehicle while under the influence of alcoholic beverages, while affected to the extent that his normal faculties were impaired, and/or did drive or was in actual physical control of a vehicle while having a blood alcohol level of 0.08 or more grams of alcohol per 100 milliliters of blood, and by reason of the operation of said vehicle, did cause or contributed to the cause of the death of Nell Marie Behr, a human being, contrary to the provisions of Sections 316.193(1) and 316.193(3)(c)3(a), Florida Statutes.

COUNT 2

RAMON GERARDO CERDA on January 14, 2023, in the County of Duval and the State of Florida, did unlawfully, by operating a motor vehicle in a reckless manner, likely to cause the death of, or great bodily harm to another, kill Nell Marie Behr, a human being, contrary to the provisions of Section 782.071(1)(a), Florida Statutes.

COUNT 3

RAMON GERARDO CERDA on January 14, 2023, in the County of Duval and the State of Florida, did then and there drive a vehicle in willful and wanton disregard for the safety of persons or property, and by reason of such driving did cause damage to the property of another, to-wit: Nell Marie Behr, contrary to the provisions of Section 316.192(3)(c)1, Florida Statutes.

COUNT 4

RAMON GERARDO CERDA on January 14, 2023, in the County of Duval and the State of Florida, did drive a vehicle, while under the influence of alcoholic beverages, when affected to the extent his normal faculties were impaired and/or while having a blood alcohol level of 0.08 or more grams of alcohol per 100 milliliters of blood, and by reason of such driving did cause or contribute to causing damage to the property of another, to-wit: Nell Marie Behr, contrary to the provisions of Sections 316.193(1) and 316.193(3), Florida Statutes.


