Additional Information

On the above-listed date and time, I was on duty in the capacity of a State Trooper with the Florida Highway Patrol, Bureau of Criminal Investigations and Intelligence. Trooper Kenneth McGeehan observed Jennifer Susan Cruz operating a white Dodge Ram 1500 bearing Florida tag 96DUNC on U.S. 90 while holding a cellular phone and recording, tailgating a vehicle and then a marked patrol car in a manner that interfered with her ability to safely operate the vehicle, in violation of Florida Statute 316.1925. Cruz followed Trooper McGeehan into the parking lot of 10769 Beach Boulevard and interfered with his lawful traffic stop by parking near the stop and yelling at him.

Upon my arrival, I contacted Cruz for the traffic violation. She provided identification via a photograph of her driver's license. A records check revealed her Florida driver's license was suspended as of June 17, 2025, for financial responsibility, in violation of Florida Statute 324.201(2). A rotation tow truck was requested.

At approximately 08:22, while the traffic stop was ongoing, Cruz willfully drove away without permission in an attempt to flee and attempt to elude my lawful traffic stop, in violation of Florida Statute 316.1935. Marked patrol vehicles activated emergency equipment and stopped Cruz, having to box her in.

After being stopped, Cruz was given lawful commands to exit the vehicle and surrender the keys. She exited but refused to surrender the keys, failing to obey a lawful order in violation of Florida Statute 316.072. Cruz then stated she was ready to fight, making a threat toward law enforcement in violation of Florida Statute 836.12(2)(a).

When Trooper First Class Jessica Manganaro attempted to retrieve the vehicle keys, Cruz struck her in the face with a closed fist causing injury to her nose and fingers, committing battery on a law enforcement officer in violation of Florida Statute 784.07(2)(b) and resisting an officer with violence in violation of Florida Statute 843.01. Cruz continued resisting arrest by tensing her body and refusing to comply with commands, in violation of Florida Statute 843.02.

While being escorted after arrest, Cruz attempted to kick Trooper First Class Manganaro, causing fear of further injury. While officers attempted to secure Cruz in a patrol vehicle, she willfully kicked at ICE Officer Alexander Martinez, U.S. Customs Air and Marine Interdiction Agent James Edgar Wyatt, and myself, striking Officer Martinez and Agent Wyatt. These actions constituted additional counts of battery on law enforcement officers, resisting with violence, and assault on a law enforcement officer, in violation of Florida Statutes 784.07(2)(b), 843.01, and 784.07(2)(a).

Due to Cruz's continued violent resistance, a taser was deployed in drive-stun mode without effect, and she was placed in a hobble restraint for safety. Cruz was transported to the Duval County Jail for booking. Trooper First Class Manganaro required hospital treatment for injuries sustained during the battery.

All events occurred in Duval County, Florida and were captured on my InCar arbitrator for FHP 1837.

Due to Trooper R. Valenzuela not having access to the computer systems, report was filed under Trooper X. Echeverria Vidal's access.


