You are commanded to appear before the undersigned Assistant Statewide Prosecutor on the **20th day of February 2026 at 2:00 P.M.**, at the Office of the Attorney General, Statewide Prosecution located at 1300 Riverplace Boulevard, Suite 405, Jacksonville, Florida, to testify truthfully and to bring the following information:

Pursuant to Chapter 16.56 and 27.04, Florida Statutes, you are commanded to produce the following items:

All records, emails, text messages, application-based communications, documents and electronically stored information that are in the possession, custody, or control of the City and its employee Yanira Cardona, specifically including those stored on agency-issued mobile devices, or personal devices used to conduct agency business, responsive to the following:

- **"Subpoena Period":** From January 2, 2026 through and including January 16, 2026.

II. Production Schedule: On or before February 20, 2026.

Specific Requests

- 1) **"Documents" or "Electronically Stored Information" (ESI):** Shall be construed in the broadest sense permissible and includes, but is not limited to, emails, text messages, SMS/MMS messages, livestreams, application postings (Facebook, Instagram, X, Signal, BlueSky, TikTok, What'sApp or similar platforms), meeting recordings or chat

logs (e.g., Zoom, MS Teams, Slack, WhatsApp), call logs, voicemails, metadata, application data, photos, geolocation data, and files stored on cloud services (e.g., Google Drive, OneDrive).

- 2) "Government Device": Any telephone, cellular phone, smartphone, tablet, laptop, desktop computer, or other portable electronic device or network issued by, owned by, or managed by the City of Jacksonville, or used by Yanira Cardona to advertise, memorialize, or discuss matters relating to City business or duties.**
- 3) "Relate to" or "Relating to" means, in whole or in part, concerning, constituting, mentioning, describing, reflecting, identifying, or pertaining to the subjects mentioned.**

4) Email Communications

All emails (including attachments) received or sent, from the email accounts of Yanira Cardona for the Subpoena Period, whether in English or Spanish, relating to:

- a. Slideshows (including Powerpoint slideshows);
- b. any activity by, location of, or interactions with, any person with United States Government or Florida law enforcement agents or agencies of any description (ICE, CBP, OHS, HSI, FHP, JSO, FDLE), or the name, identity, or vehicle operated by any member thereof,
- c. methods by which any person might avoid contact with or conceal their whereabouts from said agents or agencies;
- d. all emails (including attachments) containing the words or phrases "Nazi," "Gestapo," "stormtrooper," "terrorize," "Jennifer Cruz," or "Gamble Scott."

5) Cell Phone/Mobile Device Data

All text messages, SMS/MMS, videos, and chat messages (including mobile platforms such as Instagram, TikTok and Facebook, X, BlueSky, or applications such as Telegram, Signal or WhatsApp) stored on any Government Device used by Yanira Cardona during the Subpoena Period whether in English or Spanish, relating to:

- a. Slideshows (including Powerpoint slideshows);
- b. any activity by, location of, or interactions with any person with United States Government or Florida law enforcement agents or agencies of any description (ICE, CBP, OHS, HSI, FHP, JSO, FDLE), or the name, identity, or vehicle operated by any member thereof,
- c. methods by which any person might avoid contact with or conceal their whereabouts from said agents or agencies;

- d. all emails (including attachments) containing the words or phrases "Nazi," "Gestapo," "stormtrooper," "terrorist," "Jennifer Cruz," or "Gamble Scott."

6) Call Records and Metadata

All call logs, including phone numbers called or received, duration, and timestamps, for any phone number assigned to Yanira Cardona by the agency, whether in English or Spanish, relating to:

- a. slideshows; any activity by, location of, or interactions with any person with United States Government or Florida law enforcement agents or agencies of any description (ICE, CBP, OHS, HSI, FHP, JSO, FDLE), or the name, identity, or vehicle operated by any member thereof,
- b. methods by which any person might avoid contact with or conceal their whereabouts from said agents or agencies;
- c. all emails (including attachments) containing the words or phrases "Nazi," "Gestapo," "stormtrooper," "terrorist," "Jennifer Cruz," or "Gamble Scott."

7) Physical Inspection/Forensic Image

If electronic information is not maintained in a reasonably usable form, you are commanded to allow for a forensic image or direct inspection of the device by a qualified examiner, provided that such inspection does not unreasonably interfere with the agency's operations.

8) System Logs

All access logs, system audit trails, and data retention reports for the aforementioned devices and email accounts.

9) Any and all documents, records, reports and documentation of any kind related to the administrative suspension of Yanira Cardona.

- **PLEASE PROVIDE A CERTIFIED BUSINESS RECORDS AFFIDAVIT (ATTACHED) ALONG WITH ANY RESPONSIVE MATERIALS.**

This SUBPOENA is issued under the authority of the Circuit Court, at the request of the Office of Statewide Prosecution, by and through the undersigned prosecuting attorney. Failure to obey this Order may be punished as contempt of court. **This subpoena is issued pursuant to Section 92.605, Florida Statutes. A response is due on or before February 20, 2026, unless a longer time period is stated herein.**
