On 11/4/24, at approximately 1000 hours, the JSO Narcotics Unit Tact Team 4 was conducting a city wide buy bust operation. During the course of the operation, [REDACTED] and [REDACTED] were posing as drug users/abusers.

[REDACTED] made contact with suspect Travis Brinkley at Windle St. and Tyler St., a narcotics-related conversation ensued. During the conversation, the suspect agreed to sell [REDACTED] MDMA for \$10. [REDACTED] gave the suspect \$10 JSO funds and the suspect gave [REDACTED] MDMA at the intersection of State St. and Rushing St.

Upon completion of the transaction, a predetermined takedown signal was given, and the suspect was apprehended by [REDACTED]

The JSO funds were not recovered.

The suspect was advised of his Miranda Rights via card by [REDACTED] Post-Miranda the suspect denied any involvement.

The listed drug field tested positive for the presence of MDMA by [REDACTED] The listed property was placed into the JSO Property Room.

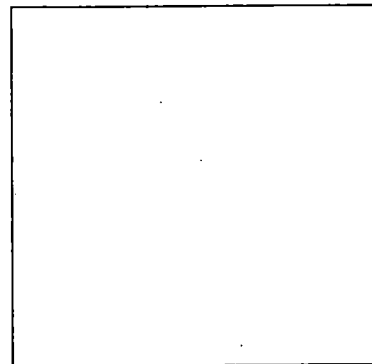
