[redacted] arrived at the meeting location prior to Dasaun Williams arrival. Simultaneously, [redacted] was positioned inside 9849 Crosshill Boulevard Jacksonville, Florida, 32222 near building 600. Prior to today's deal, Dasaun Williams sent a text to [REDACTED] on 10/17/2025 stating "I have cream to". In narcotics related conversations, cream is often referred to as crystal methamphetamine.

Prior to the narcotics transaction, electronic surveillance was conducted at 2197 Windward Cay Lane, Middleburg, FL 32068. At around 1043 hours, Dasaun Williams began backing out of 2197 Windward Cay Lane in his white Kia Optima and driving to the meetup location. [REDACTED] observed the white Kia Optima drive towards building 600, once in the complex. [REDACTED] exited his vehicle and entered the Kia Optima. [REDACTED] purchased a sum of crystal methamphetamine and fentanyl from Dasaun Williams in exchange for \$700.00 of JSO funds. At the completion of the narcotics transaction, [REDACTED] exited the Kia Optima and left the area. Shortly after, Dasaun Williams left the apartment complex.

The transaction was audio and video recorded.

Based on the totality of the investigation, your affiant believes there is probable cause to charge Dasaun Williams with multiple counts of Sale or Delivery of Fentanyl, Trafficking in Illegal Drugs, Sale of Methamphetamine, Trafficking in Methamphetamine, and Unlawful Use of a Two-Way Communication Device, as outlined above. Given the repeated narcotics transactions, the use of communication devices to facilitate the sales, and the possession of firearms during these offenses, your affiant respectfully requests that an arrest warrant be issued for Dasaun Williams for the aforementioned charges.

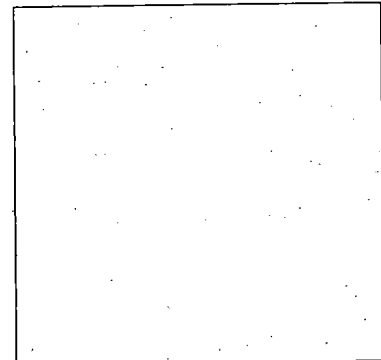

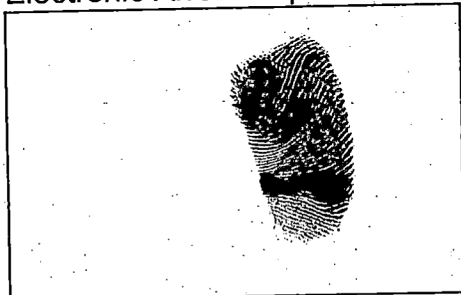
