Additional Information

On 05/27/2025 I was dispatched to 117 W. Duval Street (Duval County City Hall) to assist other officers in reference to a dispute.

Upon arrival, I was instructed by Ofc. M. Aliaga Ruiz to place Leah Grady (suspect) in the rear of my patrol vehicle and to transport her to the jail.

The following statement was provided by Ofc. M. Aliaga Ruiz.

"For the purpose of this arrest, please refer to the following:

Council Rule 4.505 – Disruption of Meeting

Any person who disrupts a Council meeting may be forthwith barred, removed, or otherwise ejected, in the discretion of the presiding officer, from further attendance at that meeting. If necessary due to the nature of the disruption, the audience may be cleared from the Council Chambers or meeting location in the discretion of the presiding officer. Furthermore, the presiding officer shall expect audience members and speakers to conduct themselves with civility and shall expect audience members to refrain from threatening behavior or language. The presiding officer may call upon the Sergeant-At-Arms to enforce directions given by the presiding officer to address violations of this Rule.

Disruption of a meeting includes the following types of behaviors:

Impeding the orderly progress of the meeting by shouting, yelling, whistling, chanting, singing, dancing, clapping, foot stomping, cheering, jeering, using artificial noise makers or musical instruments, or engaging in any other display of excessive noise, sounds, or movement;

The following narrative was written by Officer M. Aliaga #67918:

On 05/27/2025 during a Jacksonville City Council Meeting, the City Council President Randy White had warned the public several times against disruptive behavior. The listed female suspect Leah Grady, who was present for the entire meeting, was asked to leave for loudly clapping, a prohibited activity in violation of Council Rule 4.505 -Disruption of Meeting. She refused to leave and after several pleadings for her to leave willingly, she refused and a decision to arrest was made, based on Council President's Randy White's order to remove anyone found in violation.

The defendant refused to be handcuffed. Officer D. Davis #69755 came to assist with the arrest. She would not listen to orders to place her hands behind her back. Instead, she concealed her hands in front of her, tensed and pulled when her wrists were grabbed. Ultimately, we were able gain control of her arms and place her in custody.

The incident was captured on Ofc M. Aliaga #67918 BWC.

There were no injuries reported at the scene.

The defendant was transported to The PTFD by Ofc. Bellino #86053.

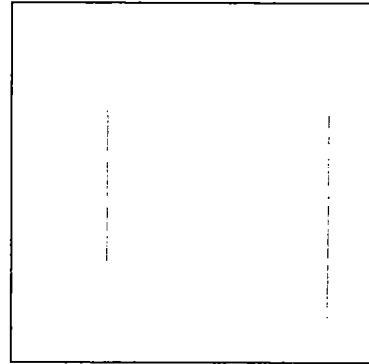
