On 04/10/2026, [REDACTED] F.S.119.071(2)(h)1 were both asked by [REDACTED] F.S.119.071(2)(h)1 victim, hereinafter referred to as [REDACTED] F.S.119.071(2)(h)1 if [REDACTED] F.S.119.071(2)(h)1 could go to a nearby park on Saturday 04/11/2026 at 1000 hours. When questioned further by [REDACTED] F.S.119.071(2)(h)1 as to why [REDACTED] F.S.119.071(2)(h)1 had to go to the park at a specific time, [REDACTED] F.S.119.071(2)(h)1 advised that [REDACTED] F.S.119.071(2)(h)1 was going to meet [REDACTED] F.S.119.071(2)(h)1 suspect, Jackson Jordan Hull (W/M DOB 25 YOA). [REDACTED] F.S.119.071(2)(h)1 advised the two discussed meeting at the park in their Canva conversation.

Canva is an online graphic design tool used to create social media post, presentations, posters, videos and logos. The application has a feature where individuals with permission can access certain projects and leave notes for the other individuals with access to see.

[REDACTED] F.S.119.071(2)(h)1 advised they were able to access the system and view certain messages between [REDACTED] F.S.119.071(2)(h)1 and the suspect. They were able to see that the suspect [REDACTED] F.S.119.011(3)(d)

[REDACTED] F.S.119.071(2)(h)1 advised the following day, they went to the park with [REDACTED] F.S.119.071(2)(h)1 and observed the suspect there. They advised that they introduced themselves to the suspect but did not confront him about the secret messages exchanged with the victim.

Upon returning home they were able to see that just before meeting, the suspect [REDACTED] F.S.119.011(3)(d)
