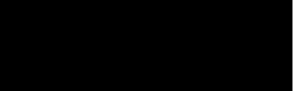

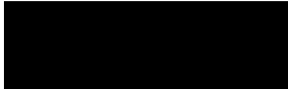

Additional Information

On 05/22/2026, I arrived at [REDACTED] and encountered the suspect James Mulvey. He was taken into custody based on the active warrant for his arrest. The warrant reads as follows:

"Your affiant, Detective C. Dickson #83608, has been employed by the Jacksonville Sheriff's Office for more than five years and is currently assigned to the Special Assault Unit.

On 05/21/2026 Special Assault Unit Detectives responded to [REDACTED] the home of juvenile victim [REDACTED]. In a recorded interview, the juvenile victim disclosed an ongoing relationship with a teacher, James Mulvey, at [REDACTED]. The relationship was initially disclosed to [REDACTED] after a concerned student brought a series of emails between Mulvey and the juvenile victim to his attention. Multiple students provided written statements regarding the atypical relationship between the suspect and the juvenile victim which included gifts and special attention. The juvenile victim [REDACTED] in Mulvey's class [REDACTED].

Emails discovered from Mulvey to the juvenile victim between their school email addresses included the following: "I won't forget about you. I don't want to forget about you. I won't forget about you. I won't replace you. I don't want to replace you. My heart remains open to you and will stay that way for as long as you allow me to be a part of your life. And I will happily say that whenever you need to hear it sweetheart." A second email included, "I love you too, baby. You're my girl. I'm not going anyplace. Thank you for being my person".

The juvenile victim sent Mulvey an email including, "I can't stop crying. I can't stop thinking you're going to leave me."

While the end of the school year drew close, the suspect requested the juvenile victim share her personal email address with him so they could continue to communicate throughout the summer.

Based on the totality of the circumstances, it is reasonable to believe the 47-year-old teacher, James Mulvey, has been engaged in a romantic, although not physical, relationship with the juvenile victim for the duration of the [REDACTED] school year based on the above referenced emails wherein the two clearly express romantic love for each other. There is probable cause to seek an arrest warrant for the actions of Mulvey as defined in Florida State Statues 800.101(2)(B)."

The suspect arrived at the Police Memorial Building, 501 East Bay Street, and was escorted to the Special Assault Unit for an interview. Prior to this interview, the suspect was advised of his Constitutional Rights, which he acknowledged he understood, and was willing to participate in without the presence of counsel. Detective J. Barnes #83603 was present when the suspect was advised of his Constitutional Rights and remained present for the entire interview. The following is a synopsis of the suspect's statement, as the entire interview was digitally recorded.

The suspect admitted to having an ongoing relationship with the victim in which he loves her and sees her as a daughter. He denied any sexual intent; however, he acknowledged having poor judgement in his communications with the victim.

The suspect was placed under arrest and transported to the John E. Goode Pre-Trial Detention Facility without incident.

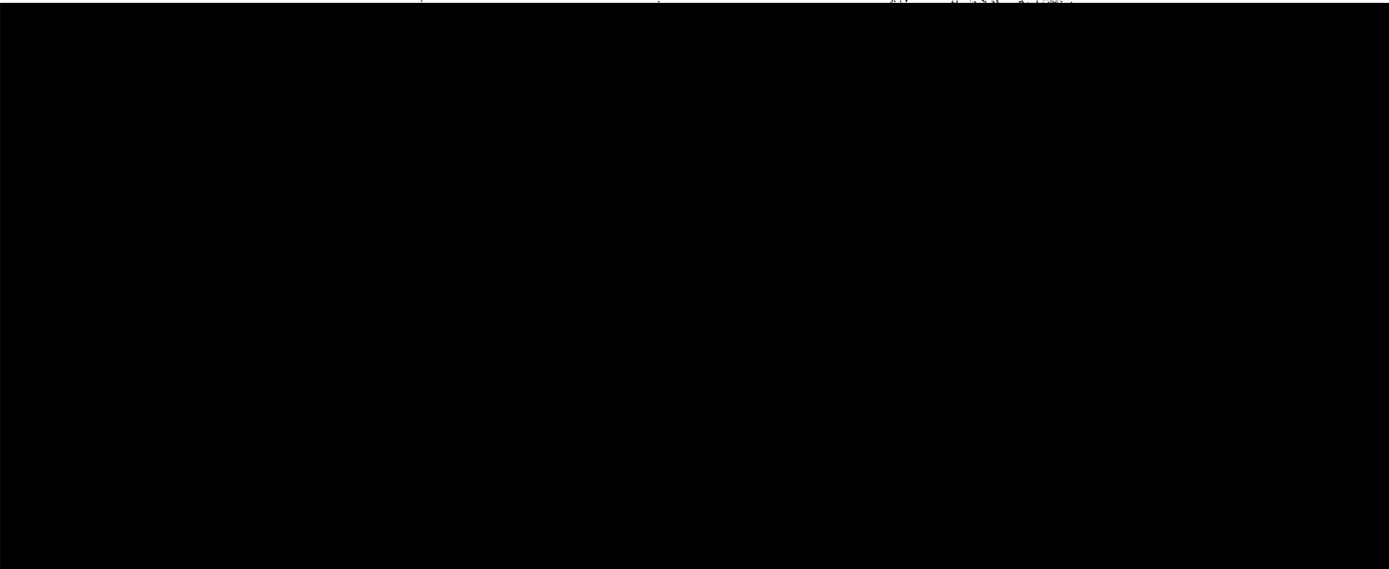
