On May 29, 2026, at 1538 hours, during the performance of the Special Assault Unit on-call duties, Sergeant D.R. Griffis (ID#65052) notified me of a lewd conduct by an authority figure investigation.

The suspect is Jon Kee Jr who is twenty seven years old. F.S.119.071(2)(h)1
The victim, F.S.119.071(2)(h)1

On May 29th, 2026, at 1656 hours an interview was conducted with F.S.119.071(2)(h)1 advised F.S.119.0 would see the suspect every day F.S.119.071(2)(h)1 but F.S.119.0 observed him working at the Circle K at F.S.119.071(2)(h)1 On the day after F.S.119.0 discovered he worked at the Circle K, F.S.119.071(2)(h)1 said to the suspect in person F.S.119.071(2)(h)1 "Hey Friend, I seen where you work at", and the suspect offered F.S.119.0 a free slushie. Yesterday (May 28, 2026), the suspect had snacks for F.S.119.071(2)(h)1 and he gave the victim a piece of candy. The suspect also gave F.S.119.071(2)(h)1 a hug (a side hug, where his hands were around F.S.119.071(2)(h)1). The suspect was already following F.S.119.071(2)(h)1 on Instagram (sometime at F.S.119.071(2)(h)1 unknown exact date). The suspect messaged F.S.119.071(2)(h)1 on Instagram and told F.S.119.0 he was now working at the Circle K on Beaches and Hodges Blvd. when F.S.119.071(2)(h)1 asked about the free slushie. The suspect then engaged F.S.119.071(2)(h)1 in conversation and provided F.S.119.0 with his cell phone number. F.S.119.071(2)(h)1 then read aloud a text thread wherein they exchanged conversation, and the suspect advised F.S.119.011(3)(d) F.S.119.071(2)(h)1 advised the conversation turned from "normal conversation", to where F.S.119.0 felt the suspect F.S.119.011(3)(d) The suspect then called F.S.119.011(3)(d)

The text thread continued after the phone conversation.

On May 29, 2026, at 1736 hours, I discussed the case with F.S.119.071(2)(h)1 following F.S.119.071(2)(h)1 interview. During this discussion, F.S.119.071(2)(h)1 agreed to call Jon Kee Jr in my presence. The following is a summary of F.S.119.071(2)(h)1 phone call with Jon; therefore, detailed statements may not be contained within this report as they are captured within the recorded call:

Jon answered the phone and referred to F.S.119.071(2)(h)1 as "friend". F.S.119.071(2)(h)1 asked Jon, F.S.119.011(3)(d)

On May 29, 2026, at 2150 hours, the suspect, Jon Kee Jr, arrived at the Police Memorial Building (PMB), 501 East Bay Street, where he was escorted to the Special Assault Unit (SAU) for an interview – Interview Room #1. Prior to this interview, Jon was advised of his United States (U.S.) Constitutional Rights, Miranda, of which he acknowledged he understood. He was willing to

participate in an interview without the presence of an attorney. The following is a summary of [Jon]'s interview; therefore, detailed statements may not be contained within this report as they are captured within the recorded statement:

Jon Kee Jr was placed under arrest for lewd conduct by an authority figure and was later transported to the Duval County jail without further incident.
