On June 29th, 2026 the Community Problem Response Unit (CPRU) was deployed in the District 6 area of Jacksonville, Florida under the Violence Reduction Strategy. BWC 26-380343

CPRU Detectives were actively looking for Michael Townsend (suspect) due to an active felony warrant for failure to report child abuse (16-2026-AF-171587-FXXX-MA).

CPRU Detective Kampfe positively identified Townsend outside his residence in the front yard. Townsend was subsequently taken into custody without incident by Detective A. Crews #88546.

86653 with ID & Records verified the active warrant.

Townsend was transported to SAU to be interviewed by detectives.

Townsend was transported to the PTFD without incident.

Case Cleared by arrest- Detective.

Warrant provided by Detective C. Dickson #83608:

"Your affiant, Detective C. Dickson #83608, has been employed by the Jacksonville Sheriff's Office for more than five years and is currently assigned to the Special Assault Unit.

On May 21, 2026, law enforcement was notified of and responded to allegations **F.S.119.071(2)(h)1** James Patrick Mulvey **F.S.119.011(3)(d)** Following an investigation, Mulvey was subsequently arrested on May 22, 2026 for Offenses Against Students by Authority Figures under section 800.101, Florida Statutes (WCN# 1770283).

In ongoing investigative efforts by the affiant, it was determined suspect Michael Aaron Townsend, **F.S.119.071(2)(h)1** **F.S.119.011(3)(d)**

Pursuant to section 39.201, "[a] person is required to report immediately to the central abuse hotline established in s.39.101, in writing, through a call to the toll-free telephone number, or through electronic reporting, if he or she knows, or has reasonable cause to suspect child abuse, abandonment, or neglect by a person responsible for the child's welfare or has reasonable cause to suspect, that a child is the victim of sexual abuse or juvenile sexual abuse shall report such knowledge or suspicion to the central abuse hotline."

Your affiant personally investigated the James Mulvey case, and has reviewed written statements from **F.S.119.071(2)(h)1** the Office of Professional Standards Investigative Report, and met with Investigator M. Valaro from OPS, and personally interviewed various administrators from **F.S.119.071(2)(h)1** This affidavit incorporates details of the expansive investigation and includes the substance of interviews conducted by OPS and JSO.

Per OPS, further corroborated by witness statements and by Townsend himself, on April 30, 2006, the suspect [REDACTED] F.S.119.011(3)(d)

My investigation revealed, the suspect [REDACTED] F.S.119.011(3)(d)

In interviews conducted by this affiant with faculty from [REDACTED] F.S.119.071(2)(h)1 in early May, [REDACTED] F.S.119.071(2)(h)1 was approached by [REDACTED] F.S.119.071(2)(h)1 with concerns [REDACTED] F.S.119.011(3)(d) [REDACTED] F.S.119.071(2)(h)1 referred [REDACTED] F.S.119.071(2)(h)1 to speak with the suspect. [REDACTED] F.S.119.071(2)(h)1 complied and spoke to the suspect and reported that she felt "blown off" and not taken seriously by the suspect.

Per OPS, on May 20, 2026, the suspect called multiple [REDACTED] F.S.119.071(2)(h)1 to his office to speak about Mulvey's behavior, all statements completed by [REDACTED] F.S.119.071(2)(h)1 were reviewed personally by this affiant. According to [REDACTED] F.S.119.011(3)(d) the suspect [REDACTED] F.S.119.071(2)(h)1 said the suspect told the group [REDACTED] F.S.119.011(3)(d)

Per OPS, the suspect called [REDACTED] F.S.119.071(2)(h)1 to his office on May 20, who had written a statement on May 19 describing Mulvey and [REDACTED] F.S.119.071(2)(h)1. According to [REDACTED] F.S.119.071(2)(h)1 the suspect advised [REDACTED] F.S.119.071(2)(h)1 that [REDACTED] F.S.119.071(2)(h)1 was going through a tough time and that the suspect had spoken to [REDACTED] F.S.119.071(2)(h)1

Your affiant spoke with [REDACTED] F.S.119.071(2)(h)1 who stated that the suspect never contacted her and that she had never personally spoken with Mulvey, but that [REDACTED] F.S.119.071(2)(h)1. However, [REDACTED] F.S.119.071(2)(h)1

During the suspect's interview on June 2, 2026, reviewed personally by this affiant, the suspect [REDACTED] F.S.119.011(3)(d)
