.On Friday, 07/10/2026, at 1905 hours officers responded to 4560 Main Street North (Jacksonville Fire Rescue Department Station 9).

Officer A. Sperruzzi #86650 provided the following statement:

"I responded to JFRD Fire Station #9 at 4560 North Main Street in reference to a stolen JFRD ambulance. Upon arrival, I spoke with Chief Williams who advised the ambulance has number 8202 on both sides of the vehicle. I immediately notified responding units via radio.

Witness 1, Dylan Anderson, who is a Firefighter with JFRD, advised he was standing inside Fire Station 9 at the listed address when around 1900, he observed the Suspect walking up to the fire station from Main Street North. He believed the Suspect was approaching the fire station for assistance. Dylan stated the Suspect **F.S.119.011(3)(d)**

He did not hear the Suspect say anything. Dylan described the Suspect as a skinny black male, with a little bit of facial hair, wearing a white t-shirt and green shorts or pants with basketball shoes on, possibly Jordans. Dylan also stated the Suspect had short, black hair and was around 25-35 years old.

Witness 2, Alex Ellison, who is an Engineer with JFRD, was on his computer at the fire station when he suddenly saw the Suspect **F.S.119.011(3)(d)**

Alex described the Suspect as a skinny black male, with a little bit of facial hair, wearing a white t-shirt and green shorts or pants.

Witness 3, JFRD Lt. Phillips advised he came outside after the Suspect left the station with the ambulance. When he got outside, he saw the ambulance heading southbound on Main Street with his crew members following behind. The crew members lost sight of the ambulance after a few minutes."

End of Officer Sperruzzi's statement.

Responding officers located the listed vehicle traveling on I-95 northbound near Dunn Avenue. The ambulance was being operated by the suspect (later identified as Amaree Wiggins) who was the sole occupant. The ambulance continued traveling to 111 Busch Drive (Anheuser-Busch) where it came to a stop. Wiggins was taken into custody at this point.

All appropriate notifications were made. Lieutenant Marrero #62662 responded. Sgt Cowan #76341 responded to the scene. Crime scene unit responded to the scene and processed the stolen vehicle.

All appropriate paperwork was completed.

Auto crimes detectives responded for further investigation. An interview was conducted and post Miranda Wiggins F.S.119.011(3)(d) A copy of the full interview was placed in the property room.

There were no other witnesses to this incident. F.S.119.071(3)

Wiggins was subsequently arrested and transported to the PDF.

Case cleared by arrest.
